outlines the steps for Board Members
and eventually co-op Members -to
participate in educational
opportunities, in line with the
identified priorities and available
budget.

This communication report is being sent from the City of Saint John/Menaquesk which is situated in the traditional territory of the Wolastoqiyik/Maliseet. The Wolastoqiyik/Maliseet along with their indigenous neighbours, the Mi'Kmaq/Mi'kmaw and Passamaquoddy/Peskotomuhkati signed Peace and Friendship Treaties with the British Crown in the 1700s that protected their rights to lands and resources.

Growth Strategy

One of the tasks in the 2024/2025 Annual Plan is to develop a Growth Strategy for NBCHC. CHF Canada provided a growth strategy worksheet, which the Board reviewed at the December meeting. The co-op will use this strategy as a roadmap to track and guide progress.

The strategy will outline the key steps needed to ensure continued development in areas such as governance, sustainability, acquisition and development, compliance, community engagement, member engagement, and overall growth.

Growth and Development

New Development

CHF Canada and New Commons
Development are conducting feasibility
studies, including environmental
assessments, site plans, and financial
evaluations, with an initial site plan
proposing 97 units in a four-level building
on a 2.54-acre parcel.

To move forward with the predevelopment work on this project the coop requires additional pre-development funding. A funding application has been submitted to the Regional Development Corporation (RDC).

<u>Membership</u>

The co-op joined the New Brunswick Non-Profit Housing Association (NBNPHA).



This membership will provide access to advocacy, resources, and information to support the co-op's growth strategy and opportunities to attend networking and educational events.

Schematic design work will begin once there is additional funding in place. CHF Canada updated the City of Fredericton on the project, receiving feedback on building location, design standards, and outdoor amenity space, with a detailed response to follow once more predevelopment funds are obtained.
